## **Finance Report**

The Treasurer summarized the following key points in his report He noted that the \$30k loss related to following,

- Continued investment in the Community Engagement Lead role again this year
- The lack of profit share from hosting 2024 Nationals was extremely disappointing. In 2023 it was \$20k +) Whilst explained in part due to a reduction in commercial and Trust funding opportunities, subsequent ANZ decision-making and late communication of the final financial position are unacceptable. AW's views have been communicated to ANZ at all levels and our experience shared with other centres to enable them to bid with full knowledge of Wellington's 2024 experience

## **GENERAL MANAGER ADDRESS**

## Acknowledgements

The GM acknowledged those noted with an Obituary in the Annual Report and asked the meeting to observe moment of silence to acknowledge the passing of those members of the AW whānau.

The GM's report was taken as read with the following key points and observations made including reviewing the questions the GM posed at the end of last year's AGM, many of the issues raised were accurate

- The pressure on funding and participation from non-traditional/virtual clubs or one-off events continues to grow
- Assistance to schools in providing zone athletics becomes even more valuable
- The Olympics presents a key focal point for attracting new members
- Initiatives such as the Youth Development Squad and Changemakers Resettlement Forum programmes were timely and successful
- Huge thanks were made to all volunteers and to those who had recently stepped up, but special mention made of the LOC for Nationals as named in the report
- Eddie Soria has agreed to step into the official's co-ordination role and to continue his education role
- Super-persons are sought for lead roles in School Engagement, Coaching, Equipment and Competitions Secretary for the coming year to help deliver our programmes

### **GENERAL BUSINESS**

Shaka Sola wished to note that increased GM involvement at children's meets would be welcomed. This point was noted, as was the intent that the Community Engagement Lead has a strong role to play in representing AW at these events.

Shaka also expressed his and the Solapower Throwing Academy's thanks for AW's donation to the javelin runway project which had seen significant use at the peak of the summer competitive season.

Peter Jack wondered if Wellington would host a Central League event this summer season. Discussion on the schedule is in train, and there was general acknowledgement that support needs to be reciprocal across the centre for league events.

Michelle Van Looy raised the need to avoid a clash between Wellington Champs and NZ Masters if possible in the upcoming season. The draft calendar is being reviewed currently and this was noted.

Bruce Atmore suggested that a session with ANZ to brainstorm how clubs can stay relevant and to share learnings would be valuable. The Chair advised that ANZ is recruiting for new roles including a National Development Manager - Central. This point will be raised with that person when they start (likely to be after the Olympics). Additionally, ANZ's CEO, Cam Mitchell, has arranged meetings with all the Centre Boards and is coming to Wellington early in September. This point can also be added to the agenda for discussion at that session and the GM can report back to clubs.

Geoff Henry proposed a public vote of thanks to Tracey Baldwin for her much appreciated support of officials at the stadium.
